

## **DCFC NATIONWIDE NOTABLE PROGRAMS**

The following incentive programs are open and accepting applications to cover some or all of the cost of Direct Current Fast Charging (DCFC), often called Level 3 charging, electric vehicle service equipment (EVSE) and corresponding infrastructure upgrades, construction, installation, and more. Most programs have strict application deadlines and requirements, and operate on a first-come, first-served basis.
